MINUTES OF PRE-BID AND SITE VISIT MEETING FOR SUPPLY, INSTALLATION, CONFIGURATION, TRAINING AND COMMISSIONING OF INTEGRATED ENTERPRISE BACKUP AND DISASTER RECOVERY SOLUTION: HELD ON TUESDAY 23<sup>RD</sup> NOVEMBER, 2021 AT 10.00 A.M. AT KCAA HEADQUARTERS. TENDER NUMBER: KCAA/018/2021-2022

### 1. Objective of the meeting

Kenya Civil Aviation herein referred to as KCAA invited bid for the supply, installation, configuration, training and commissioning of integrated enterprise backup and disaster recovery solution on Tuesday, 16<sup>th</sup> November, 2021. Prospective bidders were notified both in the advert and in the bidding documents that a mandatory pre-bid meeting would be held on **Tuesday**, **23<sup>rd</sup> November 2021** at 10.00 a.m. at KCAA Headquarters Aviation House.

The Authority will provide bidders with the required virtual resources to create virtual servers required for operationalization of the backup and recovery solution.					
7.	Does KCAA specifically require IBM Flash System or will an equivalent be acceptable?	KCAA would prefer an IBM Flash System as indicated. Nonetheless, any other appliance that meets the technical requirements provided is acceptable.					
8.	What is KCAA's requirement on training of staff?	The awarded bidder will be required to train four (4) ICT staff and undertake knowledge transfer on the deployed solution. 		the associated costs for KCAA staff based on prevailing Government rates. These include but not limited to conferencing, transport and logistics, and daily subsistence allowance (DSA). The DSA shall be payable to the four KCAA staff at an approximate rate of KES 8,400 for four night-outs. The transport costs shall be based on current AA rates for mileage.		
9.	What is KCAA's requirement Personnel capabilities	The specifications offered have indicated the various qualifications required. Refer to page 62 and 63 of the tender document on personnel capabilities.		
10.	Staff Competence	Bidders are required to attach copies of CVs and certificates of the various staff to be deployed. Refer to part B on mandatory documentation requirement. Page 31 on the tender document.		
11.	The specifications on the project plan required have been described on ITT 16.2 as well as on the mandatory service requirements item number 1. Which specifications are bidders required to adopt?	The specifications on ITT 16.2 are an enhancement of the requirements on the mandatory service requirements. Bidders are required to submit one project plan that captures both the requirements on ITT 16.2 and those on the mandatory service requirements.		
12.	OEM Professional services	Bidders to note and ensure to provide a costing for this in the price schedule.		
13.	10Gb SFP modules for the configurations	The bidder shall provide all the 10Gb SFP modules for the configurations both in the primary site and the remote site.
