1.	There is no indication of where the waste water will be drained.	East African School of Aviation is connected to a sewer line.
2.	The request for Tender Security in the Mandatory Requirements is stated to be in the format provided in the tender documents. However, the format hasn't been provided in the shared tender document.	The Tender Security form is herein attached.
3.	For the existing water network, is it mapped?	Yes. It is mapped as we have existing drawings for the distribution network.
4.	The Terms of Reference have proposed for replacement of worn out pipes. Is the consultant at liberty to propose replacement of the whole water network/system? And if yes, is the consultant at liberty to propose a new mapping of the new system?	The consultancy entails proposal for a new distribution network and taking into account the other existing infrastructure. i.e. roads and storm drain.
5.	Is fire hydrants part of the scope and is it connected to the system and the tanks?	Yes. It is connected to our existing storage tanks.
6.	Given the fluorine levels, do you have a specific treatment method or the consultant is at liberty to propose any ideal method?	There is no preferred method. The bidders are encouraged to offer proposal on the best optimal method.
7.	In case it is established that the demand for water is more than the current production, can the consultant propose for more production facilities such as a borehole?	Yes. This study and analysis is welcome.
8.	Mandatory Requirement No. 17 requires the bidder to attach a current and valid Professional Indemnity Policy/ certificate by all the experts. Professional Indemnity Policies (cover) are given for the company and not for specific staff members. What should the bidder provide in the event that the Professional Indemnity Policy doesn't stipulate the specific names of the experts?	Bidders to attach Professional Indemnity Policy for the company. Where the professional have their individual Professional Indemnity Policy, they should also attach them.
9.	On the Professional Indemnity Policy requested, what is the minimum cover and is such cover for an individual expert or the firm?	Bidders to attach Professional Indemnity Policy for the company. Where the professional have their individual
